## **TOWN OF MANSFIELD BOARD OF ASSESSORS MINUTES**

***Thursday, April 7, 2022 Meeting***

1. At 10:20 a.m., Chairperson Greg Matoian (“Chair”) opened the Town of Mansfield, MA Board of Assessors (“BOA”) meeting held in the MBC Room on the third floor of the Town of Mansfield Town Hall.
2. A roll call revealed that the following people were in attendance:
  - a) Greg Matoian, Chair,
  - b) Andrew S. Bank, Member,
  - c) Dana J. St. James, Clerk, and
  - d) Daniel C. Brogie (non-voting, Chief Assessor)
3. The BOA reviewed and approved the minutes of the March 30, 2022 BOA meeting by unanimous vote.
4. The BOA reviewed and approved the weekly motor vehicle abatements by unanimous vote.
5. The BOA reviewed and approved the FY 2022 Motor Vehicle Excise Warrant Commitment #2 by unanimous vote.
6. The Chair opened discussions on the following Old Business:
  - a) The BOA reviewed and approved the “AGREEMENT BY AND BETWEEN THE COMMISSIONER OF REVENUE OF THE COMMONWEALTH OF MASSACHUSETTS, VERIZON OF NEW ENGLAND INC. AND THE BOARD OF ASSESSORS OF THE TOWN OF MANSFIELD” by unanimous vote and signed said agreement.
7. The Chair ascertained that there was no New Business.
8. The Chair ascertained that there were no items not anticipated by the Chair 48 hours prior to this meeting.
9. The Clerk moved that the BOA go into Executive Session called under G.L.c 30A s21 (a)(7) to comply with G.L.c.59 Section 60 to:
  - a) Review the March 30, 2022 BOA Executive Session minutes;
  - b) Review one FY 2022 Clause 17D exemption; and
  - c) Review the FY2022 real estate abatement applications.


The motion passed unanimously, and the Executive Session commenced at 10:37 a.m.
