## TOWN OF MANSFIELD BOARD OF ASSESSORS MINUTES

## Wednesday, April 26, 2023 Meeting

- 1. At 6:37 p.m., Chairperson Greg Matoian ("Chair") opened the Town of Mansfield, MA Board of Assessors ("BOA") meeting held in the Town Meeting Room 2 A/B of the Town of Mansfield Town Hall.
- 2. A roll call revealed that the following people were in attendance:
  - a) Greg Matoian, Chair,
  - b) Andrew S. Bank, Member,
  - c) Dana J. St. James, Clerk,
  - d) Donna Linfield, Administrative Secretary to the BOA,
  - e) Ann MacCarthy, newly hired Chief Assessor, and
  - f) Attorney James Sullivan, Counsel to the BOA.
- 3. Donna Linfield introduced Ann MacCarthy to the BOA. Ms. MacCarthy shared her background with the BOA including her current position as the Chief Assessor for the Town of Wrentham, MA, She will begin her work as the Chief Assessor for the Town of Mansfield on May 1, 2023. The BOA welcomed Ms. MacCarthy and looks forward to working with her.
- 4. The BOA reviewed and approved the minutes of the April 5, 2023 BOA meeting by unanimous vote.
