COVID-19 Camper Waiver

Social Distancing

- All campers will be encouraged to maintain 6 feet apart to the greatest extent possible throughout the camp day.
- Signage will remind campers/counselors to maintain social distance to the greatest extent possible.
- Campers must wear face coverings or masks throughout the camp day. Further information regarding the appropriate wearing of masks will be provided daily by the Summer Camp Counselors. A back-up masked labeled with the camper's name is required to be sent to camp each day in the camper's back-pack.

Hygiene

- Campers are encouraged to wash/sanitize their hands frequently.
- Twice daily cleaning and sanitizing of bathrooms will be performed by Summer Camp Staff. Camp equipment will be cleaned and sanitized after each group use by Summer Camp Staff.

Training

- All Summer Camp Staff has been trained on social distancing and hygiene protocols.
- Campers/Counselors who display COVID symptoms may not report to Summer Camp.
- Prior to camp entry, each camper's parent/guardian will confirm daily that they are symptom-free and have not been exposed to anyone with COVID-19. Each parent/guardian will sign a statement attesting to their child's good health prior to start of each camp day.

Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. Federal and state authorities recommend social distancing as one way to attempt to prevent the spread of the virus. COVID-19 can lead to severe illness, personal injury, permanent disability, and death. Participating in Mansfield Recreation Summer Camp or accessing the Town of Mansfield facilities could increase the risk of contracting COVID-19.
